

CLOE CLEANER

Alkaline cleanser and degreaser

Description

Product: CLOE CLEANER is an alkaline cleaning degreaser based on petroleum-free raw materials. It vigorously removes oil-resin and synthetic paint residues.

Applications: suitable for cleaning machines, brushes and paint rollers. Can be used as paint stripper.

Packaging: 5 l and 20 l

Technical Data

Specific weight: approx. 1.00 +/- 0.05 g/cm³, at +20 °C

Flash point: >100 °C.

Viscosity: nd (high viscosity liquid)

PH: 13 - 14

Storage: 5 years in original closed containers. Store in a cool place, but not below 7°C. Close partially used tins carefully; if there is a particularly large air space transfer to smaller containers.

How to apply

General: mix the product well before using. Do not work at temperatures below +10°C.

Application systems: brush

Application advice: Do not use on metals with low alkali resistance (e.g. aluminium, copper, zinc). For cleaning: apply the product generously with a brush on the surface to be cleaned. Leave on for no less than 15 minutes, then rinse with water. For stubborn dirt, soak the piece to be cleaned in a solution of 8 parts water and 2 parts CLOE CLEANER for at least 8 hours, then rinse with water. To strip horizontal surfaces: apply generously on the surface and leave on; remove with a spatula. Repeat if necessary. Caution: always perform a test on the surface to be painted. Paint stripping may be incomplete on very resistant treatments (synthetic solvent-based enamels, etc.).

Consumption: depending on the degree of dirt to be treated

Dilution: CLOE CLEANER is ready to use.

Tool cleaning: with water immediately after use.

Special instructions

Check the information in the safety data sheet. WEAR SUITABLE PROTECTIVE EQUIPMENT (corrosion resistant gloves, goggles, etc.).

CORROSIVE: Contains: potassium hydroxide • Causes severe skin burns and eye damage. • Wash hands thoroughly after use. • Wear gloves, protect eyes and face.

Basic product: do not mix with acid products.

Even when applying biocompatible, petroleum-derivative-free products, the usual precautions should be taken. Always ensure adequate ventilation. Keep out of the reach of children. In the event of contact with the skin or eyes, rinse immediately and carefully with water. In case of spillage, it must be collected and disposed of properly. Do not let the product to enter drains, water courses or soil.

Disposal: Only dispose of perfectly clean containers at recycling centres. Do not dispose of soiled containers and material residues as domestic waste but at special waste collection centres. Do not dispose of the product and its residues into drains, surface water or soil.
